NAME

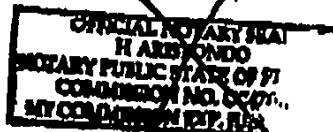
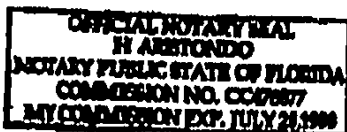
