

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being natural persons do hereby act as incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the corporation shall be: Yost Nursery, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 3055 Pollack Lane, Zephyrhills, Fl 33541.

ARTICLE III - PURPOSE

The purpose for which the Corporation is formed is to transact any or all lawful business for which organizations may be incorporated under the laws of Florida.

ARTICLE IV - TERM OF EXISTENCE

The corporation shall have a perpetual existence starting on October 1, 1997.

ARTICLE V - CAPITAL STOCK

The maximum number of shares of stock of this corporation which it is authorized to have outstanding at any one time is five hundred (500) shares of common stock at one dollar (\$1.00) par value. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote. Said stock shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code of 1986, as amended. Said capital stock shall be non-assessable and shall be payable in lawful money of the United States or in property, other than stock or securities, in lieu thereof, at a just valuation to be fixed by the board of directors of this corporation. The minimum capital with which this corporation shall begin business is \$100.00.

ARTICLE VI - REGISTERED OFFICE AND AGENT

The address of the initial registered office of the corporation is 3055 Pollack Lane, Zephyrhills, FL 33541. The name of the initial registered agent at that address is Sharane Fay Yost.

ARTICLE VII - BOARD OF DIRECTORS

The business of the corporation shall be managed by its board of directors. The initial board of directors shall consist of three (2) members. The names and addresses of the persons who will serve on the initial board of directors are:

ARTICLE VIII - SUBSCRIBER




