The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation is PRO TRAVEL ASSOCIATES, INC. (hereinafter called the "Corporation").

**ARTICLE II  
PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office and mailing address of the Corporation is 6187 NW 167th Street, Suite H-13, Miami Lakes, Florida 33015.

**ARTICLE III  
CAPITAL STOCK**

The number of shares of stock that the Corporation is authorized to issue is Three Thousand (3,000) shares of common stock, par value \$.01 per share (the "Common Stock").
