ARTICLES OF INCORPORATION

The name of the corporation is ELECTRONIC INDUSTRIES OF AMERICA, INC. (the "Corporation").

ARTICLE II

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
