ARTICLES OF AMENDMENT to the ARTICLES OF INCORPORATION of PHONE RECONNECT, INC.



WITNESSETH:

WHEREAS, PHONE RECONNECT, INC. ("Corporation") is a Florida corporation, validly formed by filing its Articles of Incorporation on October 8, 1997; and

WHEREAS, the Corporation desires to amend its Articles of Incorporation, as permitted by Article XIII of its Articles of Incorporation, to change the Corporation's name.

NOW THEREFORE, the Corporation's Articles of Incorporation are amended as follows:

1. Article I is deleted, and inserted in its place shall be:
