The name of this corporation shall be DEEVA ,INC.

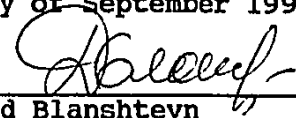

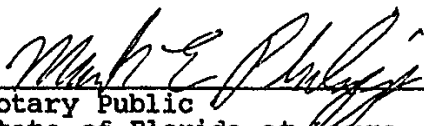
