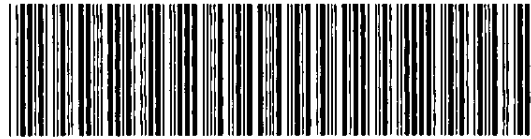

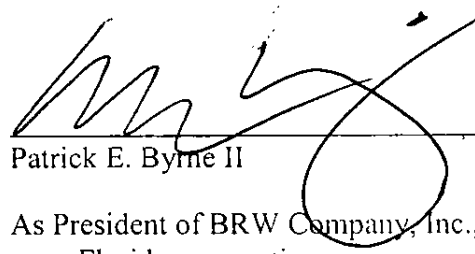
2. The name of the corporation is BRW Company, Inc. It is a Florida corporation.
