I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be GINGE MASSAGE & THERAPIES, INC., and the initial address of this corporation shall be 5669 Pacific Blvd., #2513, Boca Raton, Florida 33433.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

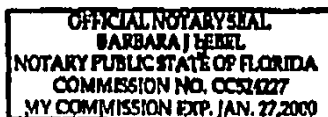
