The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

ARTICLE 1

NAME AND ADDRESS

Section 1.1 Name. The name of the corporation is JFC Communications, Inc.

Section 1.2 Address of Principal Office. The address of the principal office of the corporation is 4800 Dellwood Avenue, Jacksonville, Florida 32205.

ARTICLE 2

DURATION

Section 2.1 Duration. This corporation shall exist perpetually. CAPITAL

Section 4.1 Authorized Capital. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 100 shares of voting common stock having a par value of \$5.00 per share.

INDEMNIFICATION




