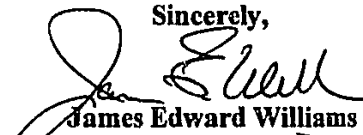

OF

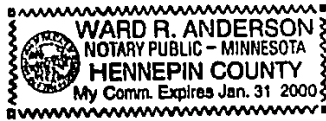

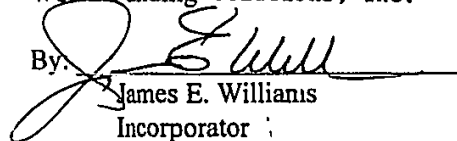
