ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICLE I. - NAME AND PRINCIPAL PLACE OF BUSINESS

The name of this corporation shall be **Cleaning Around**, **Inc.**, and its principal place of business shall be 5920 Briarwood Avenue, Sarasota, Florida 34231.

ARTICLE II. - NATURE OF BUSINESS
