The undersigned, for purposes of forming a corporation under Ahean and the layer, First of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be SEALE GROUP, INCORPORATED.

ARTICLE II DURATION

The term of existence of the corporation is perpetual.

ARTICLE III PURPOSE

The purposes of the corporation are:

- (a) To engage in the business of the wholesale and retail sale of furniture products,
