In all other respects, the current articles of incorporation, whose document number is P97000087275, shall remain the same and is hereby readopted and ratified in full.

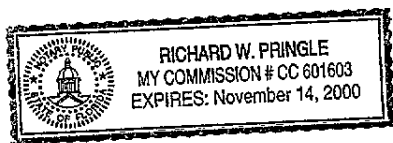
