# ARTICLES OF INCORPORATION OF TAB TECHNOLOGIES, INC

The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such Corporation:

# ARTICLE ONE

The name of the Corporation shall be Tab Technologies, Inc.

#### ARTICLE TWO

The period of its duration is perpetual.

# ARTICLE THREE

# SECTION 1: Purposes

The corporation is organized for the purpose of engaging in the business of wholesale electronics distribution and any business or actively permitted under the laws of the United States and Florida.

# SECTION 2: Powers

Subject to any specific limitations imposed by these Articles of Incorporation, the corporation shall have the following powers:

- (a) All those powers authorized by statute.
- (b) The power to carry out the purposes set forth above in any state, territory, district or possession of the United States, or in any foreign country, to the extent that such purposes are not forbidden by the law of such state, territory, district or possession of the United States, or by such foreign country.

# SECTION 1: Shares

The corporation is authorized to issue 10,000 of capital stock, all of one class, at \$1.00 par value. The shares shall be common shares. All common shares shall be identical with each other in every respects and the holders thereof shall be entitle to one vote for each share which shareholders have the right to vote. All common shares shall entitled to receive the net assets of the corporation upon its dissolution and together have unlimited voting rights.

# SECTION 1

The management of the affairs of the corporation shall be exercised by the Directors.

No contract or other transaction between (1) the corporation and one or more of its shareholders, or (2) between the corporation and any firm of which one or more of its shareholders or directors are members or employees of the corporation, or in which they are interested, or (3) between the corporation and any corporation or association of which one or more of its directors are shareholders, members, directors, officers, or employees of the corporation, or in which they are interested, shall be invalid solely because of the fact of such interest or the presence of such director or directors at the meeting of the Board of Directors of the corporation which acts upon or in reference to such contract or transaction, provided the facts of such interest shall be disclosed or known to the Board of Directors and the Board of Directors shall, nevertheless, authorize, approve and ratify such contract or transaction by a vote of a majority of the Such interested director or directors directors present. shall be counted in determining whether a quorum is present, but shall not be counted in calculating the majority necessary to carry such vote and shall not be permitted to vote upon This section shall not be construed to such question. invalidate any contract or other transaction which would otherwise be valid under the common and statutory law applicable thereto.
