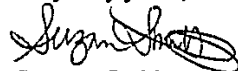

ARTICLES OF INCORPORATION

FOR

DEFENSIVE TACTICS, TRAINING & CONSULTING, INC.

The undersigned Incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME & PRINCIPAL CORPORATE OFFICE

The name of this corporation shall be: Defensive Tactics, Training & Consulting, Inc.

ARTICLE II - CAPITAL STOCK

The number of shares of stock this corporation is
authorized to have outstanding at any one time is: 100 shares common stock, no par value

ARTICLE III - REGISTERED AGENT

ARTICLE V - DURATION

This corporation shall have perpetual existence.

ARTICLE VI - PURPOSE

The purpose of this corporation is to engage in the transaction of any and all lawful business under the laws of the United States of America and of the State of Florida, including, but not limited to, Florida Security Officer School or Training Facility.

ARTICLE VII - BOARD OF DIRECTORS

All corporate power shall be exercised by and under the authority of, and the business and affairs of the corporation shall be managed under the direction of, the Board of Directors. This corporation shall have two (2) directors initially. The number of directors may be either increased or decreased from time to time by amendment of the by-laws of the corporation in a manner provided by law, but shall never be less than one.

ARTICLE VIII - BY-LAWS

The by-laws of this corporation shall be made by the Board of Directors, and may be amended, altered or rescinded by the Board of Directors at any regular or special meeting.

ARTICLE IX - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock in this corporation of the same kind, class or series, as that which he already holds, shall have the right to purchase his pro-rata thereof (as nearly as may be done without issuance of fractional shares) at the price which it is offered to others.

ARTICLE X - RIGHT OF FIRST REFUSAL

In the event that any existing shares of the corporation are offered for sale by any shareholder, or by the corporation, the remaining shareholders shall have the first right of refusal for the purchase of all or any part of any share offered for sale at a price acceptable to the seller and the corporation. In no event, shall the purchase price be less than the par value of the shares of stock. In the event that the remaining

shareholders refuse to purchase all or any part of the shares offered for sale, the corporation itself shall have the next right of refusal to purchase all or any part of any remaining shares offered to be sold at a price acceptable to the shareholder and the corporation.

ARTICLE XI - INFORMAL SHAREHOLDER ACTION

The holders of not less than a majority of the issued and outstanding shares of the voting stock of the corporation may act by written agreement without a meeting, as provided in Florida Statutes 607.0704.

ARTICLE XII - AMENDMENTS

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendments thereto, and any rights conferred upon the shareholders are subject to this reservation.
