The Undersigned, acting as incorporators of this business corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a Business Corporation under the laws of The State of Florida and adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME OF CORPORATION

The name of the Corporation shall be GARJUCAMEG CORPORATION.

ARTICLES II - TERM OF EXISTENCE

This Corporation shall begin its corporation existence of the 2nd day of October, 1997, and shall exist perpetually.

ARTICLES III - GENERAL PURPOSE

The general purpose for which this Corporation is organized shall be the operation of restaurant and related products and services and to do all things in connection therewith under the laws of The State of Florida. The business of the Corporation shall be limited to the foregoing activities.

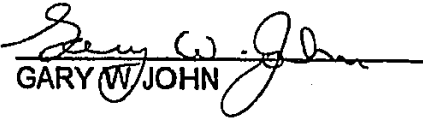
ARTICLE VII - AMENDMENT OF ARTICLES

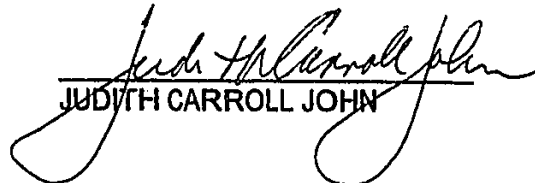
