NAME

The name of this corporation is NEW AGE PRO, INC.

ARTICLE II

BUSINESS TO BE TRANSACTED

The nature of the business to be transacted by the corporation is:

To engage in the Production, Manufacturing, Distributionm Wholesale , Retail, Importing and Exporting of Textiles, Household items and Magnet Items and the Related Services with these business functions:

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the state of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers, and privileges of ownership, including the right to vote such stock; and



