

NAME**



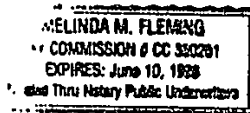
