ARTICLES OF INCORPORATION

WE, the undersigned, do hereby incorporate ourselves
for the purpose of becoming a corporation for profit under
Florida law.

ARTICLE I

The name of the corporation is: HUCKLEBERRY BUILDERS,
INC..

ARTICLE II

The corporation may engage in all types of residential
and commercial construction, and may perform all types of
restoration, renovation, and remodeling of existing structures.
The corporation may acquire, lease, improve, manage, exchange,
and sell all types of real estate. The corporation may also
conduct other enterprises and functions related to any of the
foregoing purposes that are not prohibited by law.

ARTICLE III

The aggregate number of shares which this corporation
may issue is One Hundred Thousand (100,000), all of which
shall be common shares with a par value of Ten Dollars (\$10.00)
per share. Each shareholder has full preemptive rights to
purchase shares held or owned by other shareholders of the
corporation. Each shareholder of any class of stock of this
corporation also has full preemptive rights to purchase any
corporate securities carrying rights of subscription to and/or
acquisition of, any unissued or treasury shares.
