The name of the corporation is EDEN'S HARVEST, INC. The principal address of the corporation is: 6186 Woodbury Road, Boca Raton, FL 33433.

The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.


