ARTICLE I
NAME

The name of the corporation shall be:

CAPITAL STOCK

The corporation shall be authorized to have a maximum of 100 shares of stock outstanding at one time. The share of stock authorized shall have a par value of \$ 50.00 per share.


The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the Shareholders.

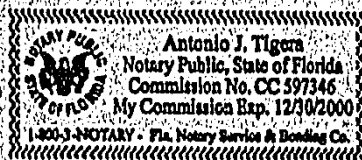


