ARTICLE ONE

The name of the corporation is **VISUAL DREAMS, INC.** The principal address of the corporation is: 3313 N.W. 101 Avenue, Sunirse, Florida 33351.

ARTICLE TWO

The period of its duration is perpetual.

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100) of no par value.**


ARTICLE FIVE


ARTICLE EIGHT
