Articles of Incorporation of PRESSURE CLEANING BY A.J., INC.

Article 1

Corporate Name

10.6.97

The name of this corporation shall be "PRESSURE CLEANING BY A.J., INC."

Article 2

Principal Office and Mailing Address

The principal office and mailing address of the Corporation is 20931-2 Via Jasmine, Boga Raton, Florida 33428.

Article 3

Nature of Corporate Business

The general nature of the business to be transacted by this Corporation shall be to engage in business for profit and it is organized for the following general purposes:

- (a) To engage in any and all lawful business permitted under the laws of the United States and the State of Florida; and
