ARTICLE ONE - NAME

**SECRETARY OF STATE
TALLAHASSEE, FLORIDA**

The name of this Corporation shall be **JUNK YARD PRODUCTIONS, Inc.** with its principal place of business located at **1012 Croydonwood Circle, Brandon, Florida 33510.**

ARTICLE TWO - DURATION

The Corporation shall have a perpetual existence, commencing on the date of filing.

ARTICLE THREE - PURPOSE

The Corporation is organized for the purpose of operating a business to provide services as follows:

- a) Engaging in minting and commercial sale of commemorative coins; and
- b) Engaging in any other activity or business permitted under the laws of the United States and the State of Florida, or necessary to carry out the purposes herein.

ARTICLE FOUR - CAPITAL STOCK

The Corporation is authorized to issue five hundred (500) shares of common stock having a par value of one dollar (\$1.00) per share.

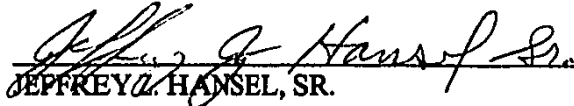
