1.1. The name of the corporation is **INTERNATIONAL IKON, INC."**

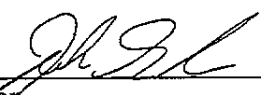
2. The foregoing amendment was adopted by the Board of Directors of the Corporation on the 18 day of December, 2000 and shareholder approval was not required.
