The undersigned incorporator hereby executes these Articles of Incorporation for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida.

ARTICLE 1

NAME

The name of this corporation shall be: Bruce A. Boyd, M.D., P.A.

ARTICLE 2

PRINCIPAL OFFICE AND MAILING ADDRESS

ARTICLE 3

CAPITAL STOCK

1. <u>Authorized Capitalization</u>. The total number of shares of capital stock authorized to be issued by this Corporation shall be:

10,000 shares of common stock, par value \$.01 per share (the "Common Stock").

REGISTERED OFFICE AND REGISTERED AGENT

The initial registered office of this corporation shall be located at 101 E.
