ARTICLE I
NAME

The name of the corporation shall be:

PRINCIPAL OFFICE


The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors and the Shareholders.

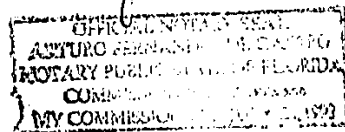


