## ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME

The name of this Corporation is Walser, Inc.

## ARTICLE II

# PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation is: 3641 Winkler Avenue Extension, Apt. # 1817, Fort Meyers, Florida 33916.

## ARTICLE III

## NATURE OF BUSINESS
