The undersigned incorporator(s) for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

### **ARTICLE 1**

### **NAME**

# **ARTICLE II**

# **TERM OF EXISTENCE**
