OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I
Name of Corporation

The name of this corporation shall be:

INNOVATIVE MEDICAL MARKETING CONSULTANTS, INC.

ARTICLE II
Nature of Business

This corporation is organized for the purpose of transacting any and all lawful business permitted under the laws of the United States of America and this State.

ARTICLE III
Capital Stock

The maximum number of shares this Corporation is authorized to issue is One Hundred (100), of One (\$1.00) Dollar par value, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

Initial Capital

The amount of capital with which this corporation will begin business is not less than Five Hundred (\$500.00) Dollars.

The corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.


