

**ARTICLES OF INCORPORATION**  
**OF**

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

**Article I - Name**

The name of this Corporation is **CLEVELAND CAPITAL CORPORATION**. The mailing address of this Corporation shall be 1715 West Cleveland Street, Tampa, Florida 33606, or such other address as may be designated by the Board of Directors.

**Article II - Capital Stock**




