ARTICLE I - NAME

The name of the Corporation shall be JS PLANNING OF SARASOTA, INC.
a Florida Corporation.

ARTICLE II - PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful
business.

ARTICLES III - POWERS

This Corporation shall have all of the powers enumerated in the
"Florida General Corporation Act", (Chapter 607,
Florida Statutes).

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 1,000 shares of voting common stock

outstanding in the names of all stockholders at such time.


