**ARTICLES OF INCORPORATION
OF

The undersigned, desiring to form a Subchapter "C" corporation in accordance with the applicable provisions of Chapter 621 of the Florida Statutes, do hereby adopt the following Articles of Incorporation.

**ARTICLE ONE
NAME**

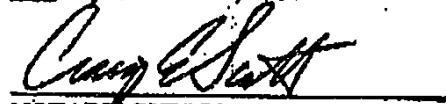
