The undersigned, being a natural person, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of forming a corporation under the Florida Business Corporation Act:

ARTICLE I NAME

The name of the corporation (hereinafter called the corporation) is Darino, Inc.

ARTICLE II PRINCIPAL OFFICE

The post office address of the initial principal office of the corporation is 3222 Lantana Road, Lantana, Florida 33406

ARTICLE III DURATION

The duration of the corporation shall be perpetual.

ARTICLE IV PURPOSE

The purpose for which the corporation is organized, which shall include the transaction of any or all lawful business for which corporations may be incorporated under the provisions of the Florida Business Corporation Act, are as follows:

To provide computer consulting services, network system sales and services, sales of computer systems, parts and software, installation, programming, setups, upgrades, troubleshooting, support, and maintenance.

To have, in furtherance of the corporate purposes, all of the powers conferred upon business corporations organized under the Florida Business Corporation Act.

ARTICLE V SHARES

The total number of shares of capital stock which the corporation has authority to issue is 2,000 shares of common stock with \$1.00 par value.


