ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF

WHEREAS, the name of the Corporation is Falcon Termite & Pest Control of Central Florida, Inc.; and

WHEREAS, the Corporation was incorporated pursuant to the provisions of the Florida General Corporation Act, on October 13, 1997 and assigned document number P97000088616; and

WHEREAS, the undersigned Corporation, by and through its Directors and pursuant to the provisions of Section 607.1001 of the Florida Statutes, wishes to amend the aforesaid Articles of Incorporation; and
