

**ARTICLES OF AMENDMENT  
TO  
ARTICLES OF INCORPORATION  
  
DONNA M. SANDERS, INC.**

*Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:*

**FIRST: Amendment(s) adopted:**

**Amendment 1: Effective January 1, 1998 the corporation is changed to a Professional Service Corporation in accordance with the provisions of Chapter 621, Florida Statutes.**

**Amendment 2: The name of the corporation shall be changed to DONNA M. SANDERS, P.A.**

**Amendment 3: ARTICLE II is amended to add the following: The corporation may not issue capital stock to anyone other than an individual who is duly licensed as a realtor in the State of Florida.**

**Amendment 4: ARTICLE V is added as follows: The purpose of the corporation shall be to provide the professional service of REALTOR in accordance with Chapter 621 of Florida Statutes.**

**Amendment 5: ARTICLE VI is added as follows: The corporation shall only render the professional service of realtor through its officers, employees and agents who are duly licensed or otherwise legally authorized to render such professional service within the State of Florida.**

**SECOND: The date of each amendments adoption: January 1, 1998.**


