TO

### ARTICLES OF INCORPORATION

## DONNA M. SANDERS, INC.

Pursuant to the provisions of section 607.1006, Florida Statues, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment(s) adopted:

Amendment 1: Effective January 1, 1998 the corporation is changed to a Professional Service Corporation in accordance with the provisions of Chapter 621, Florida Statutes.

Amendment 2: The name of the corporation shall be changed to DONNA M. SANDERS, P.A.

Amendment 3: ARTICLE II is amended to add the following: The corporation may not issue capital stock to anyone other than an individual who is duly licensed as a realtor in the State of Florida.

Amendment 4: ARTICLE V is added as follows: The purpose of the corporation shall be to provide the professional service of REALTOR in accordance with Chapter 621 of Florida Statutes.
