ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE EVA HURST COMPANIES, INC.

Pursuant to the requirements of Sections 607.1003 and 607.1006, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Incorporation of The Eva Hurst Companies, Inc. (the "Corporation"), which Corporation was incorporated under the laws of the State of Florida on October 13, 1997, under Charter No. P97000088880, and reinstated on March 23, 2000:

- 1. The members of the Board of Directors of the Corporation have recommended the following proposed change to the Articles of Incorporation to the shareholders of the Corporation, and the shareholders of the Corporation have unanimously voted to change the Corporation's Articles of Incorporation.
- a. Therefore, Article 1 of the Corporation's Articles of Incorporation shall be deleted in its entirety and the following inserted in its place:

"ARTICLE I

The name of the Corporation shall be The Eva Mae Hurst Companies, Inc. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State."

2. All other provisions of the Corporation's Articles of Incorporation shall remain in full force and effect, unaltered except as expressly provided above.

3. The foregoing amendment to the Articles of Incorporation was unanimously adopted by all the members of the Board of Directors and all the shareholders of the Corporation on the 4th day of April, 2000, and the number of votes cast for the name change amendment was sufficient for approval.
