ARTICLES OF INCORPORATION OF FRANK S. PALEN, PROFESSIONAL ASSOCIATION SECURITY ASSOCIATION ASSOCIATION

The undersigned, subscriber to these Articles of Incorporation, a natural person over the age of 18 years, competent to contract, and an attorney duly licensed to render professional services as such under the laws of the State of Florida, hereby presents these Articles for the formation of a corporation under the Professional Service Corporation and Limited Liability Company Act (Chapter 621, Florida Statutes), and other laws of the State of Florida.

ARTICLE I NAME

The name of the Corporation is FRANK S. PALEN, PROFESSIONAL ASSOCIATION (hereafter the "Corporation").

ARTICLE II DURATION

The Corporation shall have perpetual existence.

ARTICLE III PURPOSE

- A. The Corporation is organized for the sole purpose of transacting every phase and aspect of the practice of law only through officers, directors, managers, agents or employees who are qualified to render legal services in the State of Florida. Such persons shall render legal services in accordance with the Rules Regulating the Florida Bar promulgated by the Supreme Court of the State of Florida. The Corporation shall at all times comply with standards of professional conduct promulgated by such court.
- B. The Corporation may exercise the powers and privileges now or hereafter conferred upon corporations by Florida law only in furtherance of and subject to the limitations stated in the preceding paragraph III.A.

- C. The Corporation may own real and personal property necessary for the rendering of professional legal services, and to invest the funds of the Corporation in real estate, mortgages, stocks, bonds or any other type of investment.
- D. The Corporation may do anything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation, or any amendment thereof, necessary or incidental to the protection and benefit of the Corporation, and in general, either alone or in association with other corporations, firms, or individuals, to carry out any lawful pursuit necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects of the Corporation.
- E. The Corporation may enter into, for the benefit of its employees, one or more of the following: (1) pension plan; (2) a profit-sharing plan; (3) a stock bonus plan; (4) a thrift and savings plan; (5) a restricted stock option plan; or (6) other retirement or incentive compensation plans.
- F. The foregoing paragraphs shall be construed as enumerating both objects and purposes of the Corporation; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the Corporation otherwise permitted by law.

ARTICLE IV. CAPITAL STOCK

This Corporation is authorized to issue a maximum of one hundred (100) shares of \$1 par value common stock. None of the shares of the Corporation may be issued to anyone other than an individual duly licensed to render legal services in the State of Florida.

ARTICLE V INITIAL CAPITAL

The initial amount of capital with which the Corporation will begin business is \$100.

ARTICLE VI INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation is 224 Cornell Drive, Lake Worth, Florida 33460, and the name of the initial registered agent of this Corporation at that address is Frank S. Palen.

ARTICLE VII INITIAL BOARD OF DIRECTORS

This Corporation shall have one (1) director initially. The number of director(s) may be increased or decreased from time to time by amendment to, or in the manner established in the By-laws, provided that there shall always be at least one director. ARTICLE VIII INCORPORATOR

ARTICLE IX POWERS

This Corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act, the Florida Professional Service Corporation and Limited Liability Company Act, and all other corporate powers available by law.

ARTICLE X INDEMNIFICATION

This Corporation shall, to the fullest extent permitted by the provisions of the Florida General Corporation Act, as the same may be amended and supplemented from time to time, indemnify any and all persons whom it shall have power to indemnify under said provisions from and against any and all of the expenses, liabilities or other matters referred to in or covered by said provisions, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any By-law, agreement, vote of shareholders or disinterested directors or otherwise, both as to action in the official capacity of the indemnified party and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director or officer, and shall inure to the benefit of the heirs, executors and administrators of such person.

ARTICLE XI AMENDMENT

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon shareholders is and shall be subject to this reservation.
