The power to adopt, alter, amend or repeal bylaws, shall be vested in the board of directors.

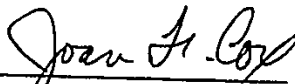
ARTICLE IX SHAREHOLDER QUORUM AND VOTING

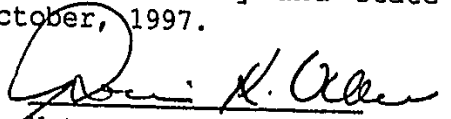
