Mr. Bedoya has never been a shareholder of Kia Dental and has no interest, now or in the past, in being an officer of Kia Dental. Mr. Bedoya being named as an officer of the corporation was unauthorized and completely inappropriate. Accordingly, Mr. Bedoya is resigning as President effective immediately. Enclosed is a copy of the formal resignation which is being filed with the Florida Department of State, Division of Corporations.


