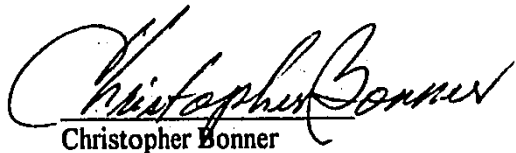

## ARTICLE ONE

THE NAME OF THE CORPORATION IS **C. BONNER INC.**

## ARTICLE TWO

THE PERIOD, TERM AND DURATION IS **PERPETUAL**

## ARTICLE THREE

THIS BUSINESS, IF GRANTED CORPORATE STATUS WILL COMMENCE ITS BUSINESS AS A FULL SERVICE STOCOCO CONSTRUCTION COMPANY, WHEREIN, WE WILL PROVIDE CONSTRUCTION SERVICES OF ALL KIND. THE BUSINESS WILL TRANSACT ALL OF ITS BUSINESS UNDER THE NAME OF **C. BONNER INC.** ALSO, IF GRANTED CORPORATE STATUS THE BUSINESS WILL CONDUCT ANY OTHER SIMILAR BUSINESS OR BUSINESSES AS THE BUSINESS MAY SE FIT FROM TIME TO TIME AS PROVIDED FOR BY STATUTE.
