ARTICLE ONE. NAME

The name of the corporation is GENESIS COMMUNICATIONS TEAM, INC.

ARTICLE NINE. AMENDMENT

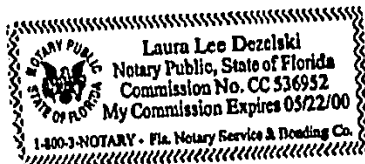
