C. To own real and personal property necessary for the transaction of the above business.

D. In general, to have and exercise all powers conferred by the laws of the State of Florida and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.

#### ARTICLE IV. - CAPITAL STOCK

A. The maximum number of shares which this corporation is authorized to have outstanding at any time shall be One Hundred (100) shares of common stock having a par value of \$.001 per share. Each of the said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the stockholders.
