ARTICLE I - NAME

The name of the corporation Mujer 2000 Inc.

ARTICLE VI - PRINCIPAL OFFICE, REGISTERED OFFICE AND AGENT

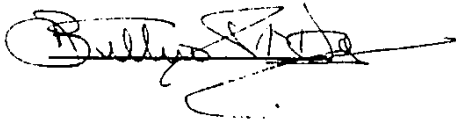
The principal office of the Corporation is at 3271 N.W. 7th Street, Suite 207 Miami, Florida 33125. This is also the registered agent's address.

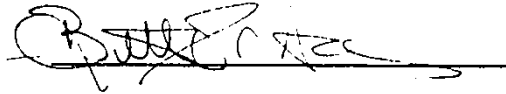

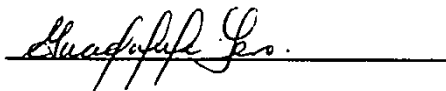
