**ARTICLE I - Name**

The name of the corporation is **CHURCH BULLETIN SERVICE, INC.**

**ARTICLE II - Duration**

This corporation shall begin its existence on October 15, 1997, and shall have perpetual existence.

**ARTICLE III - Purpose**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - Capital Stock**

#### ARTICLE XI - Indemnification


The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

stockholders is subject to this reservation.




