3. The corporation shall have the authority to issue 10,000 shares of stock.

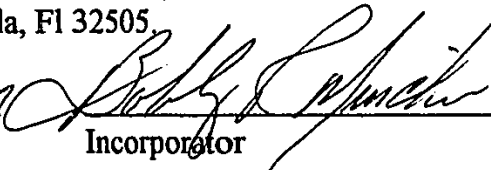
4. The registered agent of the corporation is Bobby Minchew and the registered street address is 709 Massachusetts Avenue., Pensacola, Florida 32505.
