ARTICLE I

(Name)

The name of this corporation is Peoples Contracting Company. The address of the corporation is 17221 Alico Center Road, Fort Myers, Florida 33912.

ARTICLE II

(Duration)

The corporation shall exist perpetually, unless sooner terminated according to law. Its existence shall commence upon the signing of these Articles.

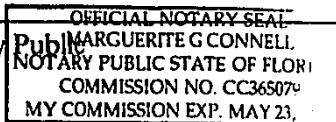


