ARTICLES OF INCORPORATION SECTOR 3 INTERNATIONAL, INC.

ARTICLE I - NAME

OF SECRETARY OF STATE

97 OCT 15 MILES

The name of this Corporation is: Sector 3 International, Inc.

ARTICLE II - DURATION

This Corporation is to exist perpetually. It shall commence existence on the date of filing of these Articles of Incorporation.

ARTICLE III - PURPOSE

This Corporation is organized for all legal purposes of in the State of Florida.

ARTICLE IV - CAPITAL STOCK
