ARTICLE 1 - NAME

The name of the corporation is HORIZON'S 5th WALL SURVEYS, INC.  
The address of the corporation is 251 Grove St., Venice, FL 34285.

ARTICLE 2 - DURATION

The duration of this corporation is perpetual beginning with the date of the filing of these Articles with the Secretary of State.

ARTICLE 3 - PURPOSE

This corporation is organized for the purpose of transacting the business of providing industrial, commercial or residential building and roof inspections and surveys, as well as transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may hereafter be amended, and any business lawful in other states and under the laws of the United States of America.

ARTICLE 4 - CAPITAL STOCK

This corporation is authorized to issue 5,000 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares".

ARTICLE 5 - PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any additional stock of the Corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE 6 - INITIAL REGISTERED OFFICE AND AGENT

ARTICLE 7 - INITIAL BOARD OF DIRECTORS

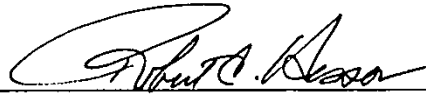
#### ARTICLE 9 - BYLAWS

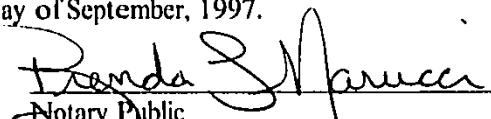
